empower more women to choose life after seeing their child on screen than those who do not have the same opportunity. Simply put, it's all about saving lives. Together, we have the amazing opportunity to support mothers, save precious babies, and leave a legacy of life for generations to come.

One hundred percent of all donations given to the Psalm 139 Project go toward the purchase of life-saving machines and training of the medical staff who will utilize them. 






# History of the Psalm 139 Project

THE PSALM 139 PROJECT began receiving funds in 2001 and placed the first ultrasound machine in 2004. In 2026, we are poised to reach over 100 total placements since the program's inception. The Psalm 139 Project has seen great success in aiding mothers to choose life with every ultrasound placement. This chart shows the continuation of placements since the beginning of the Psalm 139 Project and the dramatic spike of machines placed during a recent two-year campaign.

In December 2020, the ERLC announced an ambitious goal to place 50 ultrasound machines in pregnancy centers nationwide by January 2023,

which would have been the 50<sup>th</sup> anniversary of the disastrous *Roe v. Wade* decision. In June 2022, we celebrated the monumental *Dobbs v. Jackson Women's Health Organization* decision of the Supreme Court that overturned *Roe* and returned abortion policy back to the states. We rejoice in this outcome and yet know that there is still much work to be done in the pro-life movement. The ERLC is committed to continuing to support pregnancy centers with life-saving equipment to ensure women are empowered to choose life for their pre-born children and that families can flourish as the Lord designed.




## Esaote Partnership

THE ERLC PARTNERS DIRECTLY with Esaote for the majority of its ultrasound placements. Esaote is one of the six largest ultrasound manufacturers in the world by volume, with more than 130,000 portable and cart-based ultrasound systems installed globally. For over 20 years, the ERLC has primarily purchased ultrasound machines directly from Esaote North America. They are a unique manufacturer because they do not sell ultrasound machines to any abortion provider. As a long-term partner, Esaote gives the ERLC a discount on machines with an additional bulk price discount. This summer, Esaote updated their machines, giving us access to the latest ultrasound technology for PRCs partnering with us.

# Training Matters


OVER THE PAST 20 years, the ERLC has developed a long-standing relationship with an Esaote ultrasound consultant who helps each center with machine setup, onsite placement, and provides licensed training and continuing education training for doctors and nurses. This comprehensive training program is specifically designed for each clinic's needs and can range from one to five days. The nurses practice what they learn didactically on model patients, and additional days of hands-on training are offered to ensure the nurses have a better understanding of what they are looking for, perfecting the images, and manipulation of the machine. The nurses receive a certificate of completion at the end of the didactic and hands-on program showing them as trained in limited OB ultrasound.

## TRAINING BREAKDOWN

- Training cost is dependent on location of center and number of nurses and days needed to train clinic staff.

# ACROSS STATE LINES

REACHING ACROSS STATE LINES  
TO PROMOTE A CULTURE OF LIFE




THE VAST MAJORITY OF Southern Baptist churches are located in states with pro-life laws, but it's a different reality across state lines. When churches in one state partner with those across state lines, ultrasound machines are placed in pro-choice states that lack the same level of support for preborn children and vulnerable mothers as those in conservative states.

Pregnancy resource centers stand on the front line of the pro-life movement, especially in states where abortion access remains widespread. The ERLC's Psalm 139 Project equips these centers with ultrasound machines so women have a window into the womb—often leading them to choose life for their preborn children. By helping to fund ultrasound placements in states with few, if any, protections for these children and where mothers will often travel to receive abortions, you can reach across state lines with a missional mindset, saving preborn lives and supporting mothers facing unplanned pregnancies.

Through ["Across State Lines,"](#) a special emphasis of the Psalm 139 Project, Southern Baptist individuals, churches, state conventions, and the ERLC can work together to extend pro-life ministry into places where the need is great, offering life-saving care and the hope of the gospel.

## Recent Partnerships



### TEXAS BAPTISTS → NEW MEXICO

Texas Baptists are leveraging their resources to serve mothers and champion preborn lives in New Mexico.



### ALABAMA → ALASKA

Alabama Baptists have partnered with Alaska Baptists to save preborn lives in hard-to-reach parts of Alaska.



### ALABAMA, SEND RELIEF, NEW ENGLAND, AND TENNESSEE → VERMONT

Southern Baptists across the country are linking arms with New England Baptists to advocate for preborn lives in Vermont, where abortion remains widely accessible.

## Join Together to Save Lives

### COOPERATION, ONE OF THE GREATEST BAPTIST DISTINCTIVES

Randy Covington, former executive director of the Alaska convention, calls cooperation, such as the partnership between Alabama and Alaska, “one of the greatest Baptist distinctives.”

*“Cooperation happens when autonomous SBC organizations partner together to accomplish things we cannot do alone. Our partnership with Alabama Baptists and with the ERLC through the Psalm 139 Project has opened doors to minister through the Community Pregnancy Center in Anchorage. The placement of a new sonogram machine has significantly expanded ministry to women facing unanticipated pregnancies and provided spiritual counseling through our partnership efforts.”*

### FROM ALABAMA TO ALASKA

Dr. Rick Lance, executive director of the Alabama Baptist State Board of Missions, describes the partnership work of Alaska and Alabama Baptists like that of a military special ops team. They are going to hard-to-reach parts of Alaska, where they have to fly or take a boat because there are no roads to get them to their destination. In addition, they’re going to places where many Alaskans haven’t even been themselves.

Placing an ultrasound machine at the Community Pregnancy Center was the latest byproduct of this relationship, enabling Alaska Baptists to better advocate for the preborn and their mothers in their state.

# 2025 Placements

THIS YEAR, THE PSALM 139 PROJECT placed three new ultrasound machines that are serving a wide variety of demographics within specific communities, but all represent a strategic placement.

The following list of centers have had ultrasound machines placed through financial gifts contributed to the ERLC's Psalm 139 Project:



## COMMUNITY PREGNANCY CENTER

ANCHORAGE, AK

*Executive Director: Greg Monrad*

OPENED AS THE CRISIS PREGNANCY CENTER in 1984, The Community Pregnancy Center (also known as CPC) has been serving women and men in the Anchorage Community seeking help with unplanned pregnancies and parenting decisions for 40 years.

*"We provide pregnancy testing, limited OB Ultrasound exams, STI Testing and Treatment, Abortion Pill Reversal, Child Birth Classes, Lactation Consulting, Parenting Classes and individualized mentoring for both moms and dads, post abortion support and healing, pregnancy loss support, and material needs support.*

*"The Community Pregnancy Center is in what is known as the U-Med district with two universities, two major hospitals and many medical offices and clinics within less than a mile of our center. The Anchorage Planned Parenthood is a block down the road from our center. Our current center is in one of the original abortion clinics in Anchorage. When we purchased the building in 2013 from an oncologist, the room now used for ultrasound was being sublet to an abortion provider. A living example that God redeems not just people, but places as well!"*



Located in Anchorage, Alaska—their municipality is home to almost half of the population of the state of Alaska, and is the transportation and logistics hub for the state—especially those traveling from rural villages. It is also the medical and healthcare hub for the state as well, with many traveling in for a variety of procedures, including abortion.

## ASPIRE NOW

WILLISTON, VT

*"OUR CENTER WAS OPENED to the public in June 1985, offering pregnancy testing and on-going counseling and support with material aid. Since that time, we have expanded our services to include ultrasound, STI testing, and healthy relationship classes. Our most recent addition is a Medical Mobile Clinic that operates spring through fall. All services are free of charge.*

*"During the autumn of 1984 while in medical school, the Lord used a lecture on abortion to impress on me how crucial it was for the body of Christ to be involved in the life-and-death issue of abortion and unwanted pregnancy. The lecturer, a 'pro-choice' obstetrician, stated that she felt she could*

*never have an abortion herself and it was a very fine line that kept her in favor of doing them at all. She went on to say that she believed she would feel differently about allowing abortions if this were a perfect world where these women were supported and cared for during their stressful pregnancies."*

## ARMS OF GRACE

Executive Director: Sarah Dove


ARMS OF GRACE PREGNANCY RESOURCE CENTER is a Christian nonprofit based out of Alamance County, North Carolina. Our mission is to educate, encourage, and empower individuals along their journey of unplanned pregnancy and parenting. In 2020, God called Sarah Dove, a post abortive woman and current executive director, to begin a pregnancy resource center in the Alamance County area of North Carolina. With the help of dedicated volunteers and a working board, the ministry has been open since June of 2022.

Arms of Grace currently provides self pregnancy testing, ultrasound referrals to a mobile clinic, in-person and online educational classes, Mom and Dad support groups, one on one mentorships for fathers, abortion recovery, miscarriage support, material aid and resources, and connection to the local churches, community referrals for needs outside of Arms of Grace capacity. They currently serve a wide demographic of individuals: African American, Caucasian, and the Hispanic community, mainly in lower income situations.

We meet the client where they are with their immediate need, then walk alongside our clients offering education and resources, while offering connection and local mentorship through the surrounding church families in our community. Arms of Grace is not a medical facility currently. They partner with Triad Pregnancy Care and their mobile unit to ensure ultrasounds will be provided for their clients in need. Currently Arms of Grace

# Choosing Life Changes Lives

placed through the Psalm 139 Project are used to  
give mothers a greater understanding of the life  
that's growing inside of them. The following are  
just some of the compelling stories we have  
received this year.

## LIFE STORY #1 ----- ALBANY, NY COMPASS CARE

A PATIENT CAME TO us abortion determined and in a reported bad relationship. On her first ultrasound, she was much further along than she thought. She was actually about 16 weeks pregnant! She saw the baby moving on the ultrasound screen. We have the ultrasound projection from the machine show up on a 32-inch flatscreen with the sound of heartbeat. Due to her circumstances, she left undecided. She did not want to have an abortion but was torn. Our nurse kept in contact with her through follow-up text messages.

About two to three weeks later, she came back for another visit and repeated ultrasound. That changed her mind to continue the pregnancy, now at 19 weeks. The nurse also shared the gospel with her. She surrendered her life to Christ and went to church that Sunday. The nurses made sure she was fully connected with help and services which was her main tension. She is due in September, feeling fully supported and looking forward to a promising new future as a first-time mother.



## LIFE STORY #2 ----- HARTSVILLE, TN COMMUNITY PREGNANCY CENTER

THE WOMAN WHO STANDS out most had called a hotline. They connected her to us. She was extremely distraught over her unplanned, unwanted pregnancy. As a matter of fact, she was crying so hard, she was almost incoherent. She was afraid to tell the baby's father and did not want her boys to know. She said she was "such a fool" and there was no way could she keep this baby. She agreed to come in that morning. We listened, we loved on her, we cared about her story and gave her compassionate, factual information. We gave her an ultrasound enabling her to see her baby's heart beating. More tears flowed as she chose life. She came in regularly for classes and acquired clothing, diapers, and supplies. Eventually she learned that her baby was a long-yearned-for girl! She's gotten completely away from the abusive father, and her boys look forward to welcoming their new sister any day now. The best part is that the situation has drawn her to God. She is faithfully attending church and meeting with one of the pastors for regular counseling. Praise God!



LIFE STORY #3 ----- SHELBYVILLE, IL  
FAMILY LIFE CENTER

WHEN THIS CLIENT CAME to us, she was already a mother of seven—all of whom had been removed from her care and placed in foster homes. She believed her tubes had been tied after her last child and was overwhelmed when she found out she was pregnant again. She was heartbroken and unsure. She came in for an ultrasound, but remained undecided and unreachable for some time. Then one day, she and her partner walked back through our doors. Together, they completed prenatal classes and took steps to prepare for the birth of their baby. Not everything in her life was resolved—she still wasn't in a place where she could parent—but when her beautiful baby boy was born, her mother stepped in to care for him. She now visits him often and remains a part of his life. We are so thankful she chose *life*!

LIFE STORY #4 ----- ROGERS, AR  
LOVING CHOICES

I THINK MY FAVORITE story is our abortion reversal. She is 15 years old, and her parents took her to Kansas for an abortion. She had deep regret and wanted to parent, although she knew she was young, she felt a connection to the baby. She cried and cried and began to Google how she could save her baby. She found the abortion reversal hotline, and they connected her to us. Her parents wanted her to abort but praise God for her grandmother who told her dad that this is her decision and he would regret it if he didn't let her try. Praise God! Baby was saved! Her parents would not even speak of the baby or help her out. She had to start doing online school at home. She couldn't even come to our parenting classes. We worked it out to do the classes via Zoom and helped her in this journey. As we told her, when the baby was born, her parents fell in love with her at first sight. Baby is thriving. Mom is thriving, and the grandparents are in love! These are my favorite stories of all!

With counseling and the mother witnessing the father's response to the sonogram, she changed her mind and decided to parent.

LIFE STORY #6 ----- BOONE, NC  
THE HOPE CENTER

OVER THE PAST TWO weeks, we have seen two women who came in as abortion minded. Both were young, one being a teenager and one being college aged. While each had a very different story, one commonality for both of these ladies is that the guests they brought with them to their appointments were also encouraging them to consider choosing life. We praise God for placing these people in both of these client's lives to be used by God! Both changed their minds following the ultrasound. Being able to experience the sight of new life with their guests provided encouragement, excitement, and a fresh vision of what a beautiful life could look like even in the midst of hard situations. I believe being able to look at the pictures we sent home with them provided prompts for more conversations, and we were not only able to provide life-affirming support to the client, but were also able to empower their guests to pursue conversations for life with truth, compassion, and love.



## Focus for the Future

THE MONUMENTAL *DOBBS DECISION* of the U.S. Supreme Court that overturned *Roe* and returned abortion policy back to the states has significantly changed the abortion landscape of our nation. The Church continues to have a great opportunity to serve families in a post-*Roe* culture. Even as several states have enshrined abortion into their state constitutions, the ERLC is committed to protecting life at all stages and will seek to be a leading voice in this next chapter of the pro-life movement.

The Psalm 139 Project will continue to provide ultrasound machines to pregnancy centers to aid clinic staff with the adequate means to better serve vulnerable women and to save more preborn babies. Through our “Across State Lines” emphasis, we will continue our work to identify and place machines in pro-choice states and provide critical support for those pregnancy centers as abortion tourism continues to bring an increased number of women seeking abortions to these states and as the staff often operate under much scrutiny and increased restrictions.

Culture may change, and legislation may change, but the gospel remains the same. At the ERLC, we will continue to proclaim the glory of the Creator, the value of life, and God’s plan for the family.

Regardless of where they are located, pregnancy centers continue to share these truths as well, and we count it an honor to stand with these centers as we continue to place life-saving ultrasound machines through the Psalm 139 Project.
